

Pandora Press is an independent publisher focusing on scholarly and popular titles in Anabaptist and Mennonite Studies and beyond.



About the Press

Named after the street on which its first offices were located, the image of Pandora's box calls to mind how books can contain worlds that defy the expectations of their readers. In Hesiod's *Works and Days*, Pandora's box initially appears to contain a curse, but it also reveals a form of hope (ἐλπἰς) that entangles expectations of positive and negative futures. So too with the books that Pandora Press aims to publish.

Pandora Press collaborates with established scholars and early career researchers to produce high quality monographs, edited collections, and other literary and autobiographical texts, and we are currently expanding in new interdisciplinary directions that move within and beyond historical and theological approaches to Anabaptist and Mennonite Studies.

Founded in the early 1990s by C. Arnold Snyder, the press established itself as a leader in scholarly Anabaptist and Mennonite publishing with its flagship title *Anabaptist History and Theology*. During the 2010s the press was directed by Christian Snyder, and in early 2021 Jo Snyder's cookbook *The Vegan Mennonite Kitchen* was published to great acclaim from *Chatelaine* and CBC Radio.

In January 2022, Maxwell Kennel took over direction of Pandora Press, commissioning several new titles, translation projects, and editions. Pandora Press author and Associate Professor of History at Brock University Michael Driedger writes that, "Maxwell Kennel is ideally suited to take over direction of the Pandora Press. His energy and enthusiasm, plus his work on Mennonites and philosophy, as well as his qualifications in the area of Religious Studies, mean that he is well-situated to publish new titles in Mennonite Studies."

Since its inception, Pandora Press has published well-over 100 titles and several long-standing book series' and this new catalogue includes several titles that have long been out of print.

Although Pandora Press remains an independent publisher, informal friends of the press include the Toronto Mennonite Theological Centre, the Institute of Anabaptist Mennonite Studies at Conrad Grebel University College, the Canadian Mennonite University Press, the Commonword Bookstore and Resource Centre, the Institute of Mennonite Studies at the Anabaptist Mennonite Biblical Seminary, and Gelassenheit Publications.

Pandora Press invites manuscript submissions of both academic and popular manuscripts. Our specialization is in Anabaptist history and Mennonite theology, but we are expanding in new interdisciplinary directions and we encourage submissions from scholars across the social sciences and the humanities. Pandora Press uses double-blind peer review for its academic titles and consultation with its editorial board to ensure a high standard of quality and scholarly rigor.

A New Logo for Pandora Press

To mark the major changes that have taken place over the past year in both its directorship and vision, and to signal its movement into new and exciting futures, Pandora Press is adopting a new logo, designed by Winnipeg illustrator and designer, and author of the acclaimed graphic novel *Shelterbelts*, Jonathan Dyck (www.jonathandyck.com).

The new logo is meant to be as evocative as the name of the press, calling to mind the tumult of Pandora's box and movements between night and day that are at once cosmic and ordinary.

In addition to the new logo, new books published by Pandora Press will also include a larger and more detailed illustration that combines several themes connected to the press's identity.

This illustration is featured on the cover of this catalogue and its various parts come together to form a tableau of tensions between earth and sky, sun and moon, transcendence and immanence. The creatures – dove, deer, and fish – alongside the hooded figures and their shared book (with open, blank pages) express further mediations between human and animal, sacred and secular, life and death.

Moved by this healing story, Bridgefolk, a Mennonite-Catholic ecumenical movement in North America, centered its annual conference in 2015 on that story. Following that conference, the Mennonite Catholic Theological Colloquium convened in 2016 to consider the Christian practice of intercessory prayer and doctrine of the communion of saints from the perspectives of both traditions. This volume collects the presentations from those two events, including the personal and theological reflections of Nozomu Yamada, brother of Jun, and Alfonso Fausone, S.V.D., who initiated the intercessions for Jun.



This book is a modest effort to preserve and interpret the half century work and witness of the Mennonite Central Committee Peace Section. The Section was formed by MCC in 1942 and assigned to address "all matters that concerned witness to the nonresistant way of life on behalf of all member groups." It was organized semiautonomously, with its own board because of US Selective Service urgencies. The Section was formed in January, 1942, after Mennonites, Quakers and Church of the Brethren had spent half a decade appealing to the U. S. government for exemption of draft age men from military service. Canadian Mennonites served on the MCC board and the Peace Section in the early years, before the formation of MCC Canada in 1963. The book includes perspectives on the organizational issues between MCC Canada and MCC US. Peace Section bi-national was formed in 1974, with full Canadian-U.S. membership. The book includes Canadian perspectives and major roles of Canadian members on the bi-national Section, but only summarizes peace activities of the Canadian Peace and Social Concerns Committee and MCC Canada.




Following its change in name from Christian Peacemaker Teams to Community Peacemaker Teams, CPT Europe places significant theologicallyinformed emphases on political, economic, and public policy advocacy. The identity of CPT Europe differs markedly from traditional theological and pastoral approaches, but does not preclude theological interpretations of its work. This booklet explores how CPT Europe's work can inform a contextually sensitive, socially relevant, and liberating form of Christian faith that is immersed in the everyday lives of people, especially refugee lives. Although it is not solely a Christian organization, the work of CPT rests on a strong theological affirmation of immersion as a concrete approach to doing theology at the borders of this world. The work of CPT Europe shows how theological reflection at the borderland should not remain academic exercise, but instead it ought to emerge in the context of common people, especially the poor, the vulnerable, and the oppressed.

Hadje Cresencio Sadje is a visiting research fellow at the University of Vienna, Austria, a visiting fellow at the Toronto Mennonite Theological Centre in Canada, an associate member of the SOAS Center for Palestine Studies at the University of London-UK, and a research associate at the Cambridge Centre for Christianity Worldwide. Currently, he is a Ph.D. student at the University of Hamburg Germany.

This innovative study explores the remarkable four-hundred-year-old tradition of Hutterite songs. Helen Martens traces the origins of Hutterites' sacred songs from the time the earliest Anabaptists began writing them. These songs have been aurally/orally transmitted and sung in unison since that time.

The primary song book of the Hutterites, *Die Lieder der Hutterischen Bruder*, contains words to songs, primarily by Hutterites, which were written to a variety of melodies. The melodies range from medieval liturgical chant, court songs, sacred and secular folk songs, to the hymns emanating from the various churches after the Reformation. Many of these melodies are being sung today only by the Hutterites.

This study, begun in the 1960s, captures a tradition which is now being threatened by the fact that many Hutterites are beginning to sing fourpart music of the classical tradition and to play musical instruments, as well as furthering their education outside of the colonies. Thanks to Dr. Martens' research, the rich oral tradition of Hutterites' songs will not be lost.



The Hutterite sojourn must be considered one of the truly fascinating sagas of the last five hundred years. It is often told as a story of incredible odds, of success as well as failures, a chronicle of continuity, consistency and strength of faith in the face of oppression, persecution, forced conversions, expulsions and intolerance towards those who lived on the fringe of European society. It is an all-too-human story of prejudices and quarrels, but also of endurance, repeated beginnings and visions of a new era, for the principle of the separation of church and state grew out of the Anabaptists' dissent. Moravia marks the larger radius within which the events of the Hutterite story unfolded and played themselves out. From a superficial, cursory glance, Hutterite life appears to be shaped by tradition and, some would suggest, was stymied by it. Yet when the patina of tradition is removed and the various phases of the community's history appear, a different picture emerges, one shaped by altercations, debates, and, at times, divisions, evidence that in the final analysis Hutterites were not all that different from other religious groups. They, too, had to come to terms with a well-developed repertory of tradition on the one hand, and with the revival movements and the innovative ideas of the younger generations on the other hand.





The often-misunderstood period of Anabaptist rule in Münster in 1534-35 has cast a dark shadow over the early history of the Anabaptists. For sixteen months in 1534 and 1535 an army made up of Catholic and Protestant allies laid siege to the Westphalian city of Münster. Trapped inside the city's walls were long-time residents and new immigrants, most of whom had only recently accepted baptism as adult believers and were determined to defend their city's liberties from the army surrounding them. Their hopes to prevail came to naught. In June 1535 the siege army broke through the city's defences and slaughtered many of the inhabitants. In the generations that followed these dramatic events. historians have tended overwhelmingly to use narratives written by anti-Anabaptist polemicists as the basis for new analyses that are usually focused on the years of the siege. This book provides a revised account of Münster's Reformation. Instead of concentrating on the lurid excesses of Anabaptist rule and the polemical sources that highlighted them, it relies as much as possible on evidence from the protagonists of Münster's Reformation in both its Anabaptist and pre-Anabaptist phases. The account in this book not only concentrates on the years before 1534 and highlights the complex connections between Münster's reform activists and Dutch Anabaptists, but it also compares developments in Münster to other Reformation developments in Westphalia and beyond. The result is an antidote to histories that begin with the assumption that Münster's reformers and their Anabaptist allies were simply deranged criminals and fanatics.



Pilgram Marpeck (ca. 1495-1556) was a dedicated Anabaptist leader who was also a talented civil engineer. Marpeck possessed a keen intelligence and a passion for spiritual and biblical theology. He was one of the most original and eclectic Anabaptist thinkers. On larger projects he wrote collaboratively, with a circle of likeminded Anabaptists. Consequently, authorship of some writings has to be ascribed not only to Marpeck, but to the "Marpeck Circle". Shortly after 1600, however, his writings and his "Circle" seemingly disappeared. No distinct Marpeckite Anabaptist community survived the 17th century. This volume of writings by Pilgram Marpeck and his Circle is the first of a planned set of three, all making available previously untranslated writings.

In the 1920s, Marpeck's writings began to surface again, a result of renewed scholarly interest in the Radical Reformation. The heart of the Marpeck corpus was translated into English by William Klassen and Walter Klaassen, and published by Herald Press in 1976 (*The Writings of Pilgram Marpeck*). The writings translated and published here were not included in that volume, but they may be read in continuity with it.



The Swiss Brethren hymnal, the Ausbund, is the oldest hymnal in continuous use in the world. The Old Order Amish of North America still regularly sing selections from the Ausbund in their worship services. The "earliest hymns" of the Ausbund, translated here, refers to a group of 53 songs that were composed and sung in a castle dungeon in Passau during the years 1535-1537. These compositions were preserved and eventually published as a booklet entitled Etliche schöne christliche Geseng [Some Beautiful Christian Songs] in 1564. Nineteen years later, in 1583, these hymns became the core of the first-known publication of the Ausbund.

Robert A. Riall's expert translation of the 53 Passau hymns makes available in English this most important collection of Anabaptist hymns. More than just a translation of bare texts, Riall has annotated, analyzed and commented upon the Passau hymns, placing them in the late medieval and South German Anabaptist contexts from which they emerged. The value of this translation is further enhanced by the identification of scriptural citations and allusions in the hymns.





The Second World War and its brutal Stalinist aftermath succeeded in destroying life in the Mennonite colonies. The first-person accounts translated here tell the stories of people who almost miraculously survived successive waves of revolution, civil war, assassination, economic and political purges, and arbitrary arrest and banishment.


The letters collected in this book form the correspondence received and preserved throughout Jacob Peter Rahn's lifetime (1910 – 1991). These letters were sent from the southern Ukraine, where the Rahn family continued to live after Jacob moved to Canada. From 1930 until 1942 the Rahn family experienced and recorded the entire spectrum of events in their village during the period of dekulakization and collectivization.

These are not the letters of exceptional individuals accomplishing exceptional things but merely of people desperately trying to survive and even seeking, usually under duress, to contribute to the new system through their work and energy. 



The dislocation and devastation caused by the First World War, and more specifically the upheavals in Russia, are the major events that form the background to Orie O. Miller's MCC diary of 1920-21. The Bolshevik revolution of 1917 marked a new era of suffering and loss for Mennonite settlers in South Russia, with villages and colonies overrun repeatedly by Red and White armies and occasion-ally sacked by the anarchist forces. In 1919 the Mennonites in South Russia began reaching out to their European and North American coreligionists for help. A delegation of four representatives arrived in North America in June, 1920 and brought their appeal to various Mennonite groups. In response, the Mennonite Central Committee was born in July, 1920, to represent combined Mennonite relief efforts for South Russia.

Orie Miller had felt an early call to help the needy, and in January 1919 had volunteered to serve with the Mennonite Relief Commission for War Sufferers. For the next fifteen months he served with Near East Relief in Beirut, demonstrating strong organizational gifts. The newly-born MCC soon called on the experienced Orie Miller to be the unit director for the MCC relief mission to South Russia. He soon began writing a diary, published here, documenting the events that would unfold over the next six months. The diary captures the mundane ("I have purchased from the Near East Relief 3,000 yards of white flannelette 28 in. at 25 cents a yd.") along with the dramatic ("The closest [shell] burst about two hundred feet from our car.").

The reference to exile and empire in the title of this book is meant to invoke the themes both of settledness and of pilgrimage, of permanence and transience that have long been part of God's work in human history. To use the term empire clearly does go beyond the biblical promise of homeland, prompting unsettling questions about exploitation, domination, and idolatry. This series of three lectures is devoted to an exploration of three challenges for the current dialogue between science and religion: the challenges from hermeneutics, feminisms and postmodernisms.

Hermeneutics, the practice and theory of interpretation and understanding, deals with questions of interpreting texts and data and examines the role and use of language in religion as well as in science.

Feminist research analyzes the consequences of the interplay of masculine, feminine and gender typologies in religion and science. Examples from the history of science as well as current scientific conceptualizations indicate that beliefs in the inferiority of woman form part of our inherited scientific, religious and metaphysical framework.

The third lecture argues that postmodernism in its most constructive form shares the best fruits of modernity, especially of the Enlightenment, while at the same time avoiding some of its most serious mistakes. Drawing on the work of Nietzsche and his understanding of science, the connection between modern and postmodern, between rationality and piety is demonstrated.

A conclusion offers an outline of constructive suggestions and critical observations.


In these proceedings of the fourth annual Goshen Conference on Religion and Science, Professor Haught, Healey Professor of Theology at Georgetown University, presents the elements of his thinking on cosmic purpose and evolution in three lectures. In the discussion sessions, participants explored these ideas through questions or comments. Haught's thinking is, by his own admission, eclectic. He has blended the thoughts of others as a winemaker blends wines to bring out the nuances and sometimes hidden character of the sources. In the lectures the reader encounters Whitehead, Teilhard, Tillich, Augustine, and others.

Haught points to what he considers to be the primary messages of Christianity to help our thinking. What emerges points to a purposeful universe that embodies the restlessness that science teaches us and the Christian message of hope. To find purpose in the universe is to blend this hope with the details of the emerging universe that science probes. Haught proposes that such an understanding results in a layered explanation of what we observe. Scientific abstraction seeks simplicity, leaving out many of the nuances we know are part of our understanding of daily life. The answer is not to return to the universe of Aristotle. But if we claim that a full understanding lies in any extreme then we miss what we are seeking.



Cosmology, Evolution, and Resurrection *Hope* is a collection of lectures presented by theologian and physicist Robert John Russell at the fifth annual Goshen Conference on Religion and Science, and Russell's discussions of related topics with conference participants. In his lectures Russell develops three themes at the cutting edge of theology and science. In the first lecture he explores an often overlooked topic: the creative role of theology in the rise of contemporary natural science as evidenced in the construction of Big Bang and steady state cosmologies and the resulting debates over them. In the second lecture he turns to the problem of "natural evil" - suffering, disease, death and extinction in nature - arguing that the most compelling response to evil is a theology of redemption that embraces all of nature. In the third lecture he explores redemption through the cross and resurrection of Jesus, opening the greatest challenge to Christian theology today: the conflict between Christian eschatology and the future of the universe according to science. By placing eschatology and cosmology into a relation of creative mutual interaction, Russell believes that eschatology can begin to address this challenge and in turn it can raise potentially fruitful questions that might lead to new directions in scientific research.




The basic question that Ted Peters posed for the 2007 Goshen Conference on Religion and Science was: Where in the world is God?


To the Goshen Conference on Religion and Science of 2008 Holmes Rolston III brought three messages. These are summarized in his third lecture as three Big Bangs: the Primordial Big Bang of the universe, life's Big Bang ushering in life on Earth, and the mind's Big Bang bringing a self-conscious mind-spirit. In this conference Rolston's primary interest was focused on the latter two Big Bangs: the explosions of life on Earth and of the mind-spirit of humans on Earth.

The question remains open whether the emergence of life in general and intelligent life in particular is contingent on specific events or if life is a necessary consequence of the laws of nature. However, as Rolston points out, biologists and cyberneticists, claim that something new is introduced into the universe with the explosion of life. That something new, which Rolston considers the central concept in biology, is information. The idea that information is a causal agent was presented indirectly in a previous Goshen conference. This concept remains, however, undefined in terms of a detailed physical theory. And the idea that the mind-spirit may set us apart from other animals was not universally accepted by people at the conference. The discussions were, therefore, lively, and this was encouraged by Rolston.


What is perfection? Perfection demands an ideal, a model of how things should be. Plato embraces this concept with his realm of ideas, in which true being resides. Everything else – every person, chair, cat, book – is in the process of becoming, approaching or modeling the ideal in some way, and in other ways falling short. Aristotle, in the third book of Metaphysics, follows his master's pattern, defining perfection as that which is so good that nothing of its kind could be better. This implies that we can imagine the best, and that we have some basis by which we know that there is no better. True religion should, in some sense, be perfect, or at least we seem to expect that. But we are dealing with humans and their limited understanding. Even if we accept that God is perfect, we must confront theodicy and realize that our concept of perfection is defined by what we encounter on the earth. The capacity for self-transcendence confronts human beings with a paradox. We have a vision of "what ought to be" that is limitless, while we ourselves are finite beings. We can imagine perfection, but can we attain it?



Becoming Human provides reflections on the human person and personhood relating theological and biological concepts on how personhood leads to particular attributes that are distinctly human. The essence of personhood relates the hypostasis of biological existence to the hypostasis of otherworldliness. There have been many discussions on what makes humans unique among animals—certain DNA sequences are characteristic of humans and can be used to demarcate humans from other creatures. With regard to functional attributes, the ability to take responsibility particularly for those who are disabled or disadvantaged in some way appears to be (mostly) distinctly human. Perhaps what is most significant about humans is human language, which is open-ended and productive, allowing for an infinite set of utterances from a finite set of elements. Creativity, another perhaps unique human attribute, is linked to language, and often verbal expression leads to new ideas and perspectives. It was in naming the animals that Adam learned that he was distinct from them; as he learned about the animals, he also learned about himself. Finally, the ability to experience suffering may also be distinct among humans and somehow helps to develop the human person in a way that provides a tempering and growth.


During more than three decades, Maria Krisztinkovich collected and organized references to Anabaptist-Hutterite materials. Her work as librarian at the University of British Columbia facilitated this task. Eventually her contact with professor Werner Packull led to the conversion of her massive Hutterite bibliography into a computer data base, a task overseen by professor Peter C. Erb of Wilfrid Laurier University. The resulting bibliography is a researcher's goldmine. Included in the more than 3,000 individual entries are many extremely rare items located in eastern European archives. In 1996 prof. Packull took the manuscript with him on his sabbatical leave to Europe. During this time, the eastern European entries were checked and corrected by Rev. Oliver E. Szebeni of Hungary. The usefulness of the bibliography is enhanced by English annotations, so that readers not conversant in eastern European languages can still benefit from all entries.





Caspar Schwenckfeld von Ossig was born in 1489 into a noble family in Silesia. He became an early convert to evangelical reform, initially a follower and supporter of Martin Luther's reforms. By 1526, Schwenckfeld's spiritualist understanding of the Lord's Supper provoked vehement rejection from Luther, a breach which would never be healed. By 1529, Schwenckfeld had left his homeland and remained a religious refugee for the rest of his life. He remained a stubbornly individual thinker and biblical exegete, and a prolific writer of letters and treatises. Caspar Schwenckfeld has been described as a 'spiritualist' because of his conviction that saving faith entails the spiritual transformation of believers. However, he retained an intense interest in Scripture and the creedal traditions of the Church, which he believed confirmed his convictions.


The representative doctrinal writings translated in this volume demonstrate how Caspar Schwenckfeld appropriated and interpreted the apostolic creedal tradition, and also how he read and interpreted Scripture. The earliest of the eight doctrinal writings translated here dates from 1529, the year of Schwenckfeld's exile from Silesia; the latest dates from 1561, the year of his death. They thus provide a broad chronological representation of Schwenckfeld's early and mature thought.

The included essays show that the First Nations settlements were joined at the end of the nineteenth and in the early twentieth century by settlers from Asia and Europe, all of whom contributed significantly to the Valley's development.

The majority of the papers included in this volume were presented at First Nations and First Settlers in the Fraser Valley (1890-1960), a conference jointly sponsored by the Yarrow Research Committee and University College of the Fraser Valley on June 5-7, 2003.







When Malcolm and Esther Wenger arrived in Busby, Montana in 1944, they encountered an "utterly alien" world of beads, braids, feathers and hunters, just a few days' journey from home. The Cheyenne they met were a people whose great grandparents, 68 years earlier, had defeated George A. Custer in the Battle of the Little Bighorn. It is also the story of the five Wenger children, especially of Ann, the daughter who more than anyone else in the family absorbed Cheyenne ways, and felt the pain of the Cheyenne people. She, like the Cheyenne people as a whole, suffered serious wounds. And she, like many Cheyennes today, has overcome the wounds of a painful past and begun to heal. Her poetry and her mother and father's prose tell the stories.

Malcom and Esther Wenger were missionaries who lived on the Northern Cheyenne Reservation in Montana from 16 March 1944 to 17 August 1966.

The nighttime massacre of 136 innocent Mennonites at Eichenfeld/ Dubovka (Novopetrovka) on October 26 to 27, 1919, and elsewhere in the Nikolaipole volost during the years of 1918-1920, was one of numerous atrocities of the Russion revolution and civil war. The victims were pacifist men, women and children, neither partisans nor combatants, but peaceful villagers and visiting evangelists. The horror and insecurity of the times did not permit the dead of Eichenfeld to be openly mourned. Unwashed, they were hastily buried in shallow graves before surviving family members and villagers fled into nearby Mennonite villages. Eighty-two years later, on Sunday, May 27, 2001, Mennonites and Ukrainians gathered at the burial site to acknowledge the Eichenfeld massacre and to honor the memory of the dead. In an act of human solidarity, a large group of residents from the surrounding villages who were in attendance adopted the memorial as their own and promised to care for it. This volume tells the story of the massacre. It includes eyewitness accounts and reminiscences by Mennonites and Ukrainians.

"This slim volume brings together the accounts of Mennonite witnesses and Ukrainian recollections of the 1919 massacres by Makhno forces in the Iasykovo area with historical analysis of the civil war setting in which they took place. Noted scholars in Germany, England, the United States, and Canada here honour Peter C. Finally, Religion and Formation includes, among others, an essay on justice in postglasnost Russia, and searching, personal reflections by a longtime friend and colleague of the honoree.

The introduction traces Professor Erb's career from his Amish roots in a small town in Ontario to university studies in Waterloo and Toronto, his career as a professor and scholar of international repute, and his move from the Amish faith to Roman Catholicism. The catalogue of Professor Erb's publications lists the 17 books of which he is author, editor, or translator, his thirty-some chapters or articles in books and reference works, his more than 40 articles in refereed journals, and his forthcoming three-volume critical edition of the correspondence between Henry Edward Manning and William Ewart Gladstone.




